- > Award of 'A+' Grade in the Fourth Cycle of NAAC Reaccreditation was tremendously lauded by the members
- > Thiru. C. Vijayasingh remarked that the student strength at 3319 during the challenging pandemic time is a noteworthy achievement
- > The members applauded the significant proportion of doctoral degree holders among the team of faculty which is as high as 2/3rd of the number of staff
- The efforts of the institution under UGC PARAMARSH scheme to offer guidance to Mentee Institutions towards preparation for NAAC Accreditation were highly appreciated
- > The members positively commented that the Management grant sanctioned as Seed Money for Research projects is as tenable as UGC Minor Research grants
- > Sanctioning of student projects was observed as commendable initiative to encourage student research
- > The members complimented the installation of biogas plant in the hostel

Suggestions:

- > Dr.S.Arivazhagan threw spotlight on the need to increase the research output of science faculty in the form of publications in SCI and Scopus indexed journals
- He pointed out that the incentives for publications among the faculty members and research scholars can be apportioned based on their contribution as first author and second author and so on
- > Dr.S.Arivazhagan encouraged faculty members to apply for increased number of patents
- The number of proposals submitted to the funding agencies for Faculty and student research projects should be on the rising trend

> A pathway for self-reliant power system, by up scaling the solar power installation infrastructure in the campus, was put forward

- > Actualizing a zero discharge campus by ensuring recycling and utilization of waste water for gardening was a significant suggestion
- > The necessity of imparting aptitude skills to the final year students was highlighted by the members and they encouraged the Placement Cell to provide aptitude training equipping the students to face competitive exams and written tests and interviews in the corporate sector
- > It was remarked that faculty members may evince interest in joining increased number of NPTEL-SWAYAM ARPIT courses
